 - Should describe structure/curriculum
- ▶ Subject Code (CN050)
 - Report 180108 for all preschool courses
- ▶ Course Start Date (CN280) and Course End Date (CN290)
 - Within acceptable range of calendar dates

Staff Course (CU) Record

- ▶ Employee ID (CU050)
 - Does it match Staff Demographic (CI) and Staff Employment (CK) Records?
- ▶ Staff Provider IRN (CU120)
 - IRN of employing entity, if not reporting district

- ▶ Position Status (CK070)
 - ▶ Option U only if prior year separation not reported and zero days this year



Elementary exceptions!

➔ Search for Regular Teaching Certificates and Licenses

This search is for situations where a course master has been submitted and the student population is PR or RG (i.e., regular education courses). Every permissible combination is not found in this search. For instance, situations in which a teacher is required to have multiple teaching fields or multiple credentials do not appear.

Note that the general rule for elementary credentials (i.e., Kindergarten-Primary (KP), Kindergarten-Elementary (KE), Elementary (EL), Early Childhood (EC)) allows the teachers who hold these credentials to teach any course within the relevant grade range. These situations are not reflected within this search tool. An exception to this rule is for those initially hired on or after July 1, 2013, to teach physical education. These teachers must be licensed in PE and are included in this search tool.

When is a sub reported as teacher of record?

- ▶ In charge of the course
- ▶ Conducting activities typically completed by lead teacher
 - Provide instruction
 - Assign grades
- ▶ Even if
 - Regular teacher will be returning
 - No or incorrect credential
 - From a third-party non-EMIS reporting entity

Teacher Licensure Course (TLC) Status Report – Overview

- ▶ Indicates whether teacher is properly certified to teach course
- ▶ Certification information on report card uses *Initial* Staff and Course (L) Collection data
- ▶ Updated daily, may be impacted by other districts
 - Submit and review early and regularly
- ▶ EMIS Alliance training coming up

Multiple teachers – who appears on TLC Status Report?

- ▶ Different lengths of time
 - Teacher assigned to course for the most amount of time
- ▶ Same length of time
 - Teacher with proper certification
- ▶ Same length of time, all/none properly certified
 - First teacher selected in report generation process

Troubleshooting TLC Status Report

What to look for

- Is license valid for subject code?
- Is license valid for grade level?
- Is license valid for population?
- Are there students in the course?
- Does the Teacher State ID start with a Z?
- Does the teacher have only a substitute license? Is this a traditional public school?
- Is the credential currently valid?
- Is there a Valid in IRN?

ESSA State Licensure Assurance Report

- ▶ Displays all core academic courses and whether staff member assigned is validly credentialed to teach them
 - Per the TLC Status Report
- ▶ Changes made after close of Initial Staff/Course (L) Collection will not be reflected on report card
- ▶ Principals must review, sign, keep on file

Preschool to Kindergarten IEP Transition

- ▶ Each IEP must have a unique date
 - ▶ Only one can be in effect at a time
 - ▶ Determined by Outcome Beginning Date (GE140)
- ▶ Disability Condition 16 specific to preschool
 - ▶ Must be updated to school-age disability and outcomes upon transition to KG

NIEP Review

- ▶ Services based on a prior IEP are being provided, no current IEP is in place
 - ▶ Transfer in, adoption not complete
 - ▶ IEP expired
 - ▶ IEP not report in prior collection
- ▶ Report Disability Condition (FD130)
- ▶ Does not apply
 - ▶ Prior to initial IEP (IIEP)
 - ▶ 504 plans
 - ▶ Individualized Service Plans (ISPs)

Transfer from a Non-public

- ▶ ETR and ISP at non-public
 - Next event = IEP Completion Date-Initial (IIEP)
- ▶ ETR and IEP at non-pub, district not accepting transfer IEP
 - Next event = IEP Completion Date-Periodic Review (RIEP)
- ▶ No ETR or IEP/ISP at non-public, disability suspected
 - Follow same procedures as for any other student

Perkins V Changes for CTE

- ▶ New March (D) Follow-up post program placement category
 - ▶ Service
- ▶ Military Student Identifier (FN430) to be used for CTPD report card
- ▶ Actual date of Industry Credential to be reported
- ▶ Change in Program of Concentration criteria

Staff Changes

- ▶ Clarifications to staff reporting instructions
- ▶ Remove High Quality Professional Development (HQPD) element
- ▶ Remove Type of Appointment option for 6 hour lay teacher

College Credit Plus (CCP) Split Funding Flags

- ▶ ENRL_SPLIT_BUT_MY_LEA_TO_PAY_ALL
 - ▶ Whole payment responsibility moved to the district placing the flag
- ▶ ENRL_SPLIT_BUT_OTHER_LEA_TO_PAY_ALL
 - ▶ Whole payment responsibility moved to the other district
